Lane Ends Plaque Update on progress from Cllr. Curwen. Background; This is a private agreement to erect a plaque at Lane Ends depicting the building of Pilling Embankment. Environment Agency has agreed to the location. The Parish Council agreed, in principle, to provide a mount for the plaque provided by the family. The initial agreement involved Parish Council labour by the Parish Lengthsman, unfortunately timing forced Stan unable to continue due to pressure of Parish Council work. As a result, Cllr. S. Phillpotts volunteered to take on the project, he met with Cllr. G. Curwen and Alan Brown on site to discuss progress. Cllr. S. Phillpotts agreed to take a key role in facilitating the erection at Lane Ends.
